- 使用者需了解 1900-1912 的时间段是中国清末经历巨变的时段,在文官系统方面的反应也很突出。我们强烈建议数据库用户在使用数据库之前对这一时段的历史文献有所了解,或和熟知该时段历史的学者合作。
- 用户需理解此次公开是预公开阶段,在 2019 年后期可能还将更新,目前初定的正式公开在 2019 年十月。更新版本的公开数据将在香港科技大学李一康研究团队网站(见上文)以及中国人民大学清史所相关网站共享平台(http://39.96.59.69/)贴出。用户如在任一网站遇到下载问题可尝试另一网站。
- 用户需理解数据库是从原始资料直接转换录入的,尽可能不改变原材料的面貌,并不添加 任何录入人员对于原材料的解读。
  - 此次数据公开的数据中,我们并未尝试对原材料中任何发现的问题进行纠正。比如同一官员姓名中的某个字在不同相邻版本季节中是异体字异形字,我们尽可能遵从原著录入,若录入有困难(输入法中难以找到该字),才选择录入原字。
  - 。 此次数据公开中我们并未对数据进行处理,除了部分录入时的键入问题。
  - 。 在我们自己的数据分析中,我们对数据之间字音字形等的不一致情况进行了一定的 处理,但此类处理带入了我们对于材料本身的假设和理解,因而在数据库公开中我 们并不想加入任何此类假设。

  - o If you want to allow others to reproduce your calculations, please also share instructions and/or code to transform the data to reproduce the sample used in your analysis.
- Users will read the *User Guide* and to learn about the organization and content of the data and understand known limitations or problems.
  - Users understand that production and release of the data has been a long-term collective effort with contributions from many participants, too numerous to describe in detail here. Users will read the history of the project in the *User Guide* to learn about the participates and their roles.

- Users understand that the period between 1900-1912 was one of very rapid change in China, especially in the civil service. Users are strongly recommended to become familiar with the historical literature on this period or collaborate with historians or others who are familiar with this period.
- Users understand that this is a preliminary release and that updates may be made available over the remainder of 2019, with a goal for a final release in October 2019. Updated versions of the release will be posted at the HKUST Lee-Campbell site (link above) and at the Renmin University site (<a href="http://39.96.59.69/">http://39.96.59.69/</a>). Users who experience problems downloading at one site should try downloading at the other.
- Users understand that as much as possible, these data are a direct transcription of the original sources, and do not reflect any attempt to clean or correct problems in the original sources.
  - For this public release, we have not attempted to correct any problems we have identified in the original sources, for example, situations where a character in a name was written with different orthographies in different editions, or a character in a name was replaced by a homonym in a different edition.
  - In this public release, we have not attempted to clean the data except to resolve keystroke errors made during data entry.
  - In our own analysis, we process the data to resolve inconsistencies but this requires subjective judgment calls, and in this public release we don't want to introduce any of these assumptions.
- Users understand that there may still be keying errors as a result of coding. We encourage users
